

KALPANA CHAWLA CHHATRAVRATI YOJNA
for Engineering Students (Girls Only) for the year 2025-26

1. Introduction

To encourage meritorious girl students towards education in engineering streams and to support them for continuation of their education in engineering, Haryana State Council for Science, Innovation & Technology (HSCSIT) has started this scholarship for meritorious girl students to pursue their studies in Engineering.

2. Admissibility of Scholarship

The scholarships are limited only to the girl students who have taken admission in the first year during the year 2025-26 in Bachelor of Engineering (B.E)/Bachelor of Technology (B.Tech), Bachelor of Architecture (B.Arch) & Bachelor of Planning (B.Plan) courses.

3. Eligibility

- a) The students should have passed class X and XII Board examination from a school situated in Haryana with minimum 80% marks for Haryana Board School and 85% marks for other boards like CBSE/ICSE etc. in 12th class.
- b) The students passing X or XII board examination from a school outside Haryana have to produce Haryana Residence Certificate.

4. Number of Scholarships- Total 250 scholarships for girls only (200 scholarships for students admitted in B.E/B.Tech courses and 25 scholarships each for students admitted in B.Arch. and B. Plan courses).

5. Amount of Scholarships: Rs. 8350/- per month for students selected on the basis of rank in JEE (Advanced) examination and Rs. 4500/- per month for students selected on the basis on rank in JEE (Mains) examination.

6. Selection Criteria/Preparation of Merit List :

- a) Merit list for selecting students in each category will be firstly prepared as per the All India Ranking in JEE (Advanced) examination, in case sufficient applications are not received from applicants possessing All India Rank in JEE (Advanced) examination, then applications from candidates possessing All India Rank in JEE (Main) examination shall be considered for preparing merit list in each category. While applying online for this scholarship students have to upload their JEE (Mains/Advanced) examination Score Cards attested by the Head/Principal/Director/Registrar of College/Institute/University in which they have taken admission.

- b) The students shall be selected on the basis of merit list prepared as mentioned in above sub-clause; however, student who does not applies for this scholarship shall not be considered for this scholarship irrespective of his/her marks in the qualifying exam.

7. In case of tie preference will be given as under:

- a) To students having higher average percentage score obtained in class 12th board examination in Physics, Chemistry & Mathematics (i.e. Total of three subjects divided by maximum marks in three subjects = %age).
- b) Preference to language score better of (English/Hindi) in 12th class board.
- c) If tie still persists, Student younger in age will be preferred.

8 Distribution of 250 Scholarships:

For B.E/B.Tech: 200 scholarships will be given as per below distribution:

- a) In case of sufficient students do not apply for B.Arch and B. Plan trades or vacant scholarships are left out of the total scholarships available for B.Arch and B. Plan trades, then these vacant scholarships will be given to the students of B.E/B.Tech trade.
- b) Only the candidates having the permanent disability of not less than 40% (being otherwise fit for admission to the course) will be considered for admission as Physically Handicapped. Disability certificate must be issued from Chief Medical Officer of the concerned District. Physically Handicapped candidates belonging to Haryana are required to upload the handicap certificate as per **Annexure-III** at the time of applying online and later-on, if selected, have to produce the same in original. Same should be updated/ verified on the PPP portal also.
- c) Children & Grand-children of Freedom Fighters of Haryana are required to upload a certificate from the Deputy Commissioner of the concerned District as per **Annexure- IV** at the time of applying online.
- d) The candidates claiming reservation for Ex-Servicemen (ESM) categories of Haryana are required to submit the certificate duly issued by Zila Sainik Board/CO/Competent Authority with office seal as per the sub-category applicable, at the time of applying. The seats reserved for ESM category shall be offered in order of following priorities:
 - I. Widows/Wards of Defense personnel killed in action.
 - II. Wards of disabled in action and boarded out from service.
 - III. Widows/Wards of Defense personnel who died while in service with death attributable to military service.
 - IV. Wards of disabled in service and boarded out with disability attributable to military service.
 - V. Wards of Ex-Servicemen who are in receipt of Gallantry Awards: -
 - i. Param Vir Chakra
 - ii. Ashok Chakra
 - iii. Sarvottam Yudh Seva Medal
 - iv. Maha Vir Chakra
 - v. Kirti Chakra
 - vi. Uttam Yudh Seva Medal
 - vii. Vir Chakra
 - viii. Shaurya Chakra
 - ix. Yudh Seva Medal
 - x. Sena, Nau Sena, Vayu Sena Medal
 - xi. Mention-in-Despatches
 - VI. Wards of Ex-Servicemen

- e) In case of sufficient applications are not received in a particular sub-category, then vacant scholarship(s) of that sub-category shall be transferred to other sub-category under that category, further in case if still there are vacant scholarships in a category, these vacant scholarships will be merged in the General category.
- f) The parents of BC candidates (Block A & B) for benefit of reservation for their ward shall have to verify their annual family income verified from their PPP ID during applying online to the effect that they do not fall under the creamy layer at the time of admission as per notification no. No. 40/13/2024-1SW dated 16 July, 2024 or may submit the BC Category Certificate issued after 16 July, 2024.
- g) Separate Merit Lists shall be prepared for each category i.e. Gen, SC (SC & SCD), BC [BC(A) & BC(B)], PH & ESM/FF.
- h) While applying on the portal candidates have to upload self-attested certificates related to their Castes i.e. SC/BC etc.

9 Continuation of Scholarship :

- a) Students are advised to submit their self attested semester Mark-sheets through their institutions immediately after the declaration of result, preferably within 1 month of announcement of semester results to facilitate the payment of scholarship. Internet/Scanned copies of the Mark-sheets received through email will not be considered.
- b) The Scholarships are awarded to the students on the basis of performance in the semester examination. For continuation of scholarship the selected students have to maintain at least 60% marks in each semester. In case of SGPA/SPI or any other index awarded by the University, the conversion would be done as per University's/Institute's approved formula. In case such University Institute's formula is not available, the percentage will be derived by scaling down the SGPA/SPI by 10%. For example the SGPA/SPI is 6 on 10 point scale; the equivalent percentage would be taken as 54%.
- c) In case the Institute/University is awarding SGPA/SPI or any index, the students are required to send the Institute/University approved conversion formula from SGPA/SPI to equivalent %age.
- d) The students are advised to submit undertaking along with the DMC of each semester that he or she is not availing any other scholarship. The undertaking should be attested by the College/Institute authority.

- e) The scholarship will be paid to the students for all the twelve months in a year starting from the month in which the admission is taken. It will be generally from July (admission year) to June (next year).
- f) The scholarship will be released to the students in two half yearly installments semester wise. First installment will be released on selection, the 2nd installment on the basis of performance of 1st Semester, 3rd installment on the basis of performance of 2nd semester and so on.
- g) Candidates having Compartment / Re-appear in semester examination will not be considered for further installment of scholarship.
- h) In case of re-appear or below 60% marks in any of the semester, the future installments of scholarships of the students will be discontinued. Candidates clearing the re-appear in supplementary examinations will not be considered for continuation of scholarships.

10 Scholarship shall be regulated with the following terms and conditions :

- a) The students selected under this scheme are not entitled for any other scholarship.
- b) The applications received through online mode/portal will only be entertained. The applications received by other mode will not be considered.
- c) Please ensure that all the columns of the application are correct before submitting. No claims shall be entertained in case of incomplete or non-submitted application.
- d) The applications received online will be scrutinized and a merit list will be prepared as per the criteria of the scheme.
- e) All offers made initially shall be 'Provisional'. This shall be confirmed based on the verification of original documents by this office or by the concerned institute where the student is studying. At the time of registration candidates have to submit a certificate in the prescribed format as per **Annexure-II**, that she is not availing any other scholarship along with this scholarship. The certificate is to be countersigned by the head/principal/registrar of the college / university / institute. The candidate shall also submit the Enrolment certificate duly certified from the Head /Principal / Registrar / Director of the College / University / Institute as per prescribed format as per **Annexure-I**. Later on HSCSI&T may obtain the documents/certificates uploaded by the candidates as per different Annexure for verification, in original from the candidates selected.

- f) Any change or re-admission to another College/ University/ Academic Institute within the same academic year (in same semester) is acceptable, provided the scholar pursues same engineering/architecture/planning stream. The offer would stand invalid in case this change or re-admission occurs in the next academic year and thereon, or engineering stream is different. In such a case, there will be no scope for restoration of the offer and no communication would be made separately to student.
- g) The scholarships will be disbursed directly to the students in their bank accounts through online (NEFT / RTGS). All the students while applying shall have to open their accounts in the banks having Electronic Transfer / ECS facility and furnish the bank details like Name of bank, branch address, IFSC code and account number in the application format for online transfer (RTGS / NEFT) of scholarship. The student must ensure that their bank account number should be linked with Aadhar Number & KYC is done.
- h) Only regular students will be eligible to apply for this scholarship. The students studying privately or through correspondence / distance mode or in unrecognized institutions will not be eligible for this scholarship.
- i) The students should not be involved in any type of indiscipline or unfair means.
- j) Self Attested photocopies of all the certificates from 10th onwards will have to be uploaded with the application on the portal.
- k) HSCSIT will have the right to increase/decrease the number of scholarships or make changes in the scheme.
- l) If a student is found to have obtained a scholarship by false statement, her scholarship will be cancelled forthwith and the amount of the scholarship paid will be recovered, at the discretion of HSCSIT.
- m) In case of any confusion/dispute decision of Secretary, Executive Committee HSCSIT will be final.
- n) Sanction in respect of selected students will be issued by this office after verification of original documents, submission of the proof of enrolment certificate and other relevant papers duly certified from the Head /Principal /Registrar /Director of the College /University / Institute.

- o) The candidates are advised to provide personal mobile number and email id during registration. Same will be used to communicate any advisory/ notification related to selection for this scholarship scheme and for future communication. Candidates are also advised to not change their personal mobile number and email id and keep them active. In case of change of mobile number of the candidate in future same shall be updated in the HSCSIT office.
