Subject: - Extension of deadline for clearance of pending cases for AY 2022-23 under Post-Matric Scholarship Scheme for SCs and Pre matric Scholarship Scheme of SC & others –reg.

This is in reference to the Post-Matric Scholarship (PMS) schemes. The SEWA Department, vide letter no. Edu-3/2025/15569-75 dated 19.12.2025, has forwarded a directive from the Government of India, vide letter No. K-11017/8/2025-SCD-V dated 16.12.2025.

Regarding the subject mentioned above, letters (Memo No. KW (1) 17/42-2022 Sch (2)) dated 23.10.2025, along with reminders dated 14.11.2025, 27.11.2025, 04.12.2025 and 10.12.2025 have already been sent to you. However, a significant pendency still exists.

In this regard, all Principals/Nodal Officers of the concerned Universities/Colleges/Institutions are requested to expedite the verification process and clear the pendency for the Academic Years 2022-23 to 2024-25 urgently. Please ensure that the L-1 level verification of all students for AY 2022-23 to 2024-25 is completed by 31.01.2026, and the L-2 level verification is completed by 15.02.2026. This will enable payments to be processed after the verification of the L-3 level for the students without further delay. A report of the same must be sent to this office as well.

All Registrars of the concerned Universities and Principals of concerned Government, Aided, Self-Financing, Education, and Law colleges shall be held responsible for any lapse in this matter. If the Department faces any litigation after the specified timelines, the respective institutions will be held accountable, and any resulting payments shall be made at their own cost.
